1 Introduction

1.1 This Privacy Policy applies to your use of <u>https://www.furniturespot.co.za</u> (the "Website").

2 Privacy Policy

2.1 For the purposes of this section, Personal Information will be understood in accordancewith the definition provided in the Protection of Personal Information Act 4 of 2013 ("the Act"). Furniturespot also subscribes to the principles for electronically collecting personal information outlined in the Act, and the further legislation referred to therein. We endeavour to ensure the quality, accuracy and confidentiality of Personal Information in our possession.

2.2 In adopting this Privacy Policy, we wish to balance our legitimate business interests and your reasonable expectation of privacy. Accordingly, we will take all reasonable stepsto prevent unauthorised access to, or disclosure of your Personal Information. However, it is impossible to guarantee that your Personal Information shall be 100% secure.

2.3 Users will be prompted to register an account with Furniturespot. In so doing, users may be asked to provide the following information (Personal Information):

2.3.1 First name;

2.3.2 Surname;

2.3.3 Email;

2.3.4 Phone number;

2.3.5 Physical address; and

2.3.6 Company / CC / business name.

2.4 We will attempt to limit the types of Personal Information we process to only that to which you consent to (for example, in the context of online registration, newsletters, message boards, surveys, polls, professional announcements, SMS, MMS and other mobile services), but, to the extent necessary, your agreement to these this Privacy Policyconstitutes your consent as contemplated in section 69 of the Act.

2.5 Subject to the Terms of Service, sales are concluded through the Website and all payment information will be captured through the Website. However, Furniturespot shall not retain payment information on behalf of its users.

2.6 We will not collect, use or disclose sensitive information (such as information about racial or ethnic origins or political or religious beliefs, where relevant) except with your specific consent or in the circumstances permitted by law.

2.7 By agreeing to the terms contained in this Privacy Policy, you consent to the use of your Personal Information in relation to:

2.7.1 The provision and performance of the services;

2.7.2 Informing you of changes made to our Website;

2.7.3 The provision of marketing related services to you by Furniturespot;

2.7.4 Responding to any queries or requests you may have;

2.7.5 Developing a more direct and substantial relationship with users for thepurposes described in this clause;

2.7.6 Developing an online user profile;

2.7.7 Understanding general user trends and patterns so that we can develop and support existing and ongoing marketing strategies;

2.7.8 For security, administrative and legal purposes; and

2.7.9 The creation and development of market data profiles which may provide insight into market norms, practices and trends to help us improve our offering to you. Such information will be compiled and retained in aggregated form, but shallnot be used in any way which may comprise the identity of a user.

2.8 You further consent to the sharing of your Personal Information with the following categories of third parties:

2.8.1 Selected courier services;

2.8.2 Social media and website analytics service providers;

2.8.3 Mass-mail service providers;

2.8.4 Customer support service software providers;

2.8.5 Third-party accounting software;

2.8.6 Web-based business tools, such as Zoho; and

2.8.7 Operating systems service providers.

2.9 Although absolute security cannot be guaranteed on the internet, Furniturespot has in place up-to-date, reasonable technical and organisational security measures to protect yourPersonal Information against accidental or intentional manipulation, loss, misuse, destruction or against unauthorised disclosure or access to the information we process online.

2.10 While we cannot ensure or warrant the security of any Personal Information you provide us, we will continue to maintain and improve these security measures over time inline with legal and technological developments.

2.11 We store your Personal Information directly, or alternatively, store your Personal Information on, and transfer your Personal Information to, a central database. If the location of the central database is located in a country that does not have substantially similar laws which provide for the protection of Personal Information, we will take the necessary steps to ensure that your Personal Information is adequately protected in that jurisdiction.

2.12 Your information will not be stored for longer than is necessary for the purposes described in these Terms or as required by applicable legislation.

2.13 The Personal Information Furniturespot collects from users shall only be accessed by Furniturespot employees, representatives and consultants on a need-to-know basis, and subject to reasonable confidentiality obligations binding such persons.

2.14 Furniturespot shall have the right, but shall not be obliged, to monitor or examine anyinformation and materials including any website link that you publish or submit to Furniturespot for publishing on the Site. You shall be solely responsible for the contents of all material published by yourself.

2.15 We constantly review our systems and data to ensure the best possible service to ourusers. We do not accept any users, or representatives of users, under 18 years of age or who otherwise does not have the relevant capacity to be bound by this Privacy Policy.

2.16 We will not sell, share, or rent your Personal Information to any third party or use your e-mail address for unsolicited mail. Any emails sent by Furniturespot will only be in connection with the provision of our services and/or the marketing thereof.

<u> 3 Log Files</u>

3.1 When you visit Furniturespot, even if you do not create an account, we may collect information, such as your IP address, the name of your ISP (Internet Service Provider), your browser, the website from which you visit us, the pages on our Website that you visit and in what sequence, the date and length of your visit, and other information concerning your computer's operating system, language settings, and broad demographic information. This information is aggregated and anonymous data and does not identify you specifically. However, you acknowledge that this data may be able to be used to identify you if it is aggregated with other Personal Information that you supply to us. This information is not shared with third parties and is used only within Furniturespot on a need-to-know basis. Any individually identifiable information related to this data will never be used in any waydifferent to that stated above, without your explicit permission.

4 Cookies

4.1 Furniturespot uses cookies. A cookie is a small piece of information stored on yourcomputer or smart phone by the web browser. The two types of cookies used on the Website are described below:

4.1.1 "Session cookies": These are used to maintain a so-called 'session state' and only lasts for the duration of your use of the Website. A session cookie expires whenyou close your browser, or if you have not visited the server for a certain period of time. Session cookies are required for the Platform to function optimally, but are notused in any way to identify you personally.

4.1.2 "Double Click Cookies" Third party vendors with whom we contract may use



cookies to serve a user ads based on a user's prior visits to the Website. Users may, however, opt out of receiving these ads by visiting www.aboutads.info.

4.1.3 "Permanent cookies": These cookies permanently store a unique code on yourcomputer or smart device hard drive in order to identify you as an individual user. No Personal Information is stored in permanent cookies. You can view permanent cookies by looking in the cookies directory of your browser installation. These permanent cookies are not required for the Furniturespot Website to work, but may enhance your browsing experience.
